






## **New biodiversity data resources**

# Improved accuracy for the World Database on Protected Areas

- Several data updates received from multiple countries in a single year for the first time in 2019.
- South Africa now update their national dataset quarterly.
- Peru send updates whenever changes are made.
- Updates are available in the WDPA the following month.
- Reduced time between a site being gazetted / degazetted and the change being reflected in the WDPA.

Ocean+ Library addresses this need for information by providing an overview of global marine and coastal datasets of biodiversity importance, including some datasets of regional interest.


Over 100 metadata sheets now available, including 10 new sheets

## **Biodiversity Measures**

### **Biodiversity Indicators for Extractives**

- Piloting of the draft methodology conducted in 2019.
- Workshop to review the emerging findings, the business case for developing indicators, and links to other indicator initiatives.
- Results of the pilots will be used to update and revise the methodology.

### **Aligning Biodiversity Measures for Business**

- Aims to form a common view on the measurement, monitoring and disclosure of biodiversity for business.
- Convened a two day technical workshop in Brussels in March 2019 and a three day workshop in Rio de Janeiro, Brazil in October 2019.
- Workshops involved more than 50 institutions working on biodiversity measurement approaches for business.
- Substantial progress has been made in identifying common ground among measurement approaches.
